- The Government of the Republic of Kenya has applied for financing from KfW and the EU-AITF, towards the cost of the Mombasa - Mariakani (A109) Highway, Lot 2: Kwa Jomvu - Mariakani (30.4 km), and intends to apply part of the financing for Consultancy Services for Project Management, Construction Supervision and Contract Administration. The project road is situated in Mombasa and Kilifi Counties in the Coastal Part of Kenya and forms part of the 500 km Mombasa-Nairobi highway. The part of the road, which is planned to be upgraded starts at Kwa Jomvu within Mombasa County. It runs in a northerly direction through Miritini, Mazaras, Mariakani, after the Weighbridge.
- The road project is an enlargement and upgrading of an existing road and not a new road, which would need a new right of way, but resettlement will be required in several sections of the road. The scope of services of this assignment includes project management, construction supervision (**including supporting the PEA during the first year of the 5-year maintenance period**) and contract administration.
- The Consultancy Services will be delivered under a time-based contract time for an envisaged duration of 42 months, as follows: Phase I: Construction Supervision & Contract Administration (30 months) and Phase II: Defects Notification Period and initial year of maintenance (12 months).
- The tender process is subject to KfW's Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries. A copy can be obtained from <https://www.kfw-entwicklungsbank.de>
- The contract will be awarded to an independent firm or group of firms with proven experience in similar road projects and a minimum annual turnover over each of the last three years of Euro 10 Million.
- The Project Executing Agency is under no obligation to shortlist any consultant who expresses an interest. Should the Tender be cancelled, the tenderers are not entitled to any compensation, nor will any reasons be given for the cancellation.
