The above subject refers.

The National Treasury has designed an end to end Electronic Government Procurement (e-GP) System that will replace the current manual procurement in all public procuring entities in both the National and County Governments effective 1<sup>st</sup> July, 2025.


The National Treasury has employed a phased incremental approach to implement the system. The e-GP system incorporates e-requisition, e-tender preparation, e-tender submission, e-tender evaluation, e-tender award, e-bid security and guarantee management module, e-contract Management modules among other modules.

As part of the implementation of the system, The National Treasury conducted Training of Suppliers Registered with Pilot Procuring Entities on Electronic Government Procurement (E-GP) System Supplier Registration, E-Tender Submission and E-Contract Management Modules from 14<sup>th</sup>-17<sup>th</sup> April, 2025 at Kenya School of Government, Lower Kabete Campus. The participants included suppliers/ consultants/contractors registered with KeNHA.

In the new e-GP system, procurements will be conducted online right from bidding to contract management stage.

The purpose of this notice is to communicate this policy and the Government's intention to change the conduct of procurement system in the public sector. This is to request you to register your company(ies) in the e-GP portal before the end of June, 2025 so as to be eligible to participate in future public procurement proceedings.

### ROLLOUT OF THE ELECTRONIC GOVERNMENT PROCUREMENT SYSTEM

### NOTICE TO ALL SUPPLIERS, CONTRACTORS & CONSULTANTS

The National Treasury is rolling out an end-to-end Electronic Government Procurement (e-GP) System to all Procuring Entities in both the National and County Governments. This is one of the public finance management reforms that is geared towards efficiency and value for money in public procurement. The e-GP system rollout is in line with the directive by His Excellency, the President in his State of the Nation address on 21st November, 2024 that the National Treasury rolls-out the e-GP system by the first quarter of 2025.

The implementation and use of the e-GP system will result in reduced cost of goods, works and services; increased transparency in procurement processes and practices; improved efficiency in procurement by minimizing the procurement cycle time; maximization of value for money; accountability; improved confidentiality, integrity and authenticity of transactions between procuring entities and suppliers; streamlined procurement procedures across the government through standardization of processes and practices; and enhanced procurement information management that will facilitate procurement planning, monitoring, evaluation and reporting.

Suppliers/Contractors/Consultants are required to self-register on the e-GP portal that is accessible through [www.egpkenya.go.ke](http://www.egpkenya.go.ke). In addition, they are requested to note the following:

- Supplier Registration Module Manual is available on the e-GP Portal; and
- The National Treasury will organize weekly supplier registration webinar every Thursday commencing **10<sup>th</sup> April 2025 to 30<sup>th</sup> May 2025**. Suppliers will be required to register for training through links provided on [www.egpkenya.go.ke](http://www.egpkenya.go.ke) under Supplier Training. Only suppliers who have registered for training will be invited to the webinar.
